

MINUTES OF MEETING OF BARNHAM BROOM PARISH COUNCIL HELD ON 19th JANUARY 2017 AT 7.30 PM IN THE VILLAGE HALL

Present: Cllrs Burns (JB), Cowan (JC), Edward (Jed), Ewles (JEw), Garrard (PG) and Read (BR)(Chair).

3. Adjournment for Public Participation

The meeting was adjourned at 7.31pm to allow members of the public to speak

Two residents wished to speak on items 6b. A family who lived and worked in the village for the last 10 years were recently evicted and are living with residents. They asked the Council to write to South Norfolk Council and Saffron Housing to highlight the situation and raise concerns that local people are not being given first option on properties.

Sara Harrold reported that she attended a meeting with Ian Alston to hear about his plans for the foodhub. She reported that he had explained his existing sites have a very limited impact on the local environment and assured that traffic would have to access the site via the Easton roundabout. Sara felt that any increase in traffic caused by further development would have an impact on rat running in the village. She noted that there are benefits for the local economy and employment and asked that the Parish Council support Barford & Wrampingham Parish Council in their response to the LDO consultation.

8. Village Issues

- Memorial Garden working party. Three residents have started clearing brambles from the site. The Clerk has obtained a quote of £185 for eight hour hire of a digger and a driver from a company suggested by JB. There was discussion about the best way forwards and it was agreed that BR

would arrange for digger hire and contact Michael Harrold to move the waste soil to the playing field. Proposed: JB, Seconded: PG. **BR to action.**

- SAM2 sign – it was suggested that the Clerk should contact the other Parishes who share the sign to see if they would be interested in selling their share to Barnham Broom. **Clerk to action.**
- Dog fouling is an issues around the school and in the park. JEd has advertised this on the community facebook page. **Clerk to purchase ‘no dog fouling’ signs.** Proposed: JEd, seconded: JC
- There have been complaints about the lights which are shining from Eastern Power Systems, Hill Farm, Watton Road. **Clerk to forward contact details to JEd.**

There was lengthy discussion and it was agreed that the Parish Council should leave Norfolk ALC and join Norfolk PTS for 2017/18. The new website to be used from April 1st. There have been 2 applicants and their information was circulated. It was agreed that the interview panel should consist of JC, JEw and JB and the decision to appoint delegated to this panel. **The Clerk to arrange interview schedule for third week in February.** Proposed: BR, seconded: PG
