# STANDING ORDERS – EXTRACTS (2a, 3e, 3f, 9a & 9c)

### **BARNHAM BROOM PARISH COUNCIL**

#### 2. DISORDERLY CONDUCT AT MEETINGS

a. No person shall obstruct the transaction of business at a meeting or behave offensively or improperly. If this standing order is ignored, the chairman of the meeting shall request such person(s) to moderate or improve their conduct and failing this be excluded from the meeting.

#### 3. MEETINGS GENERALLY

- e. Public participation shall be included on the agenda for a maximum of 15 minutes unless directed by the Chairman. Comments must be directed to the Chairman.
- f. A question posed by a member of the public need not be answered or start a debate. The chairman may direct when a written or oral reply will be given.
- 9. MOTIONS FOR A MEETING THAT REQUIRE WRITTEN NOTICE TO BE GIVEN TO THE PROPER OFFICER
- a. A motion shall relate to the responsibilities of the meeting for which it is tabled and, in any event, shall relate to the performance of the Council's statutory functions, powers and obligations or an issue which specifically affects the Council's area or its residents.
- c. The Proper Officer will decide on whether or not to include any motion on the agenda. An explanation, if requested, on its exclusion shall be given by the Proper Officer. A motion received which is not clear in meaning will be rejected by the Proper Officer.
